SALARIES (STATUTORY OFFICES) ADJUSTMENT.

No. 39 of 1957.

An Act to increase the Salaries payable to the Holders of certain Statutory Offices, and for purposes connected therewith.

[Assented to 12th September, 1957.]

BE it enacted by the Queen's Most Excellent Majesty, the Senate, and the House of Representatives of the Commonwealth of Australia, for the purpose of appropriating the grant originated in the House of Representatives, as follows:--

- 1. This Act may be cited as the Salaries (Statutory Offices) short title. Adjustment Act 1957.
- 2. This Act shall be deemed to have come into operation Commenceon the first day of July, One thousand nine hundred and fifty- ment. seven.

3.—(1.) The Acts specified in the first column of the First Amendment of Schedule to this Act (being Acts fixing the salaries payable to the holders of the offices respectively specified in the second column of that Schedule) are amended as respectively specified in the third column of that Schedule.

- (2.) Section one hundred and eighty-two of the *Income Tax* and Social Services Contribution Assessment Act 1936-1956 is amended by omitting the words "Thirty-five thousand pounds" and inserting in their stead the words "Forty-three thousand pounds ".
- (3.) Section one of the Public Service Act 1957 is amended by omitting sub-section (3.).
- 4. Each Act specified in the first column of the Second Citation of Schedule to this Act, as amended by this Act, may be cited in Acts. the manner specified in the second column of that Schedule opposite to the reference to that Act in the first column.
