REGULATIONS MADE UNDER THE SULPHATE OF AMMONIA BOUNTY ACT 1962.*

I, THE ADMINISTRATOR of the Government of the Commonwealth of Australia, acting with the advice of the Federal Executive Council, hereby make the following Regulations under the *Sulphate of Ammonia Bounty Act 1962*.

SULPHATE OF AMMONIA BOUNTY REGULATIONS.

1. These Regulations may be cited as the Sulphate of Ammonia Citation. Bounty Regulations.

2.—(1.) In these Regulations, unless the contrary intention appears— Interpretation.

“authorized agent” means a person appointed in pursuance of regulation 3 of these Regulations to be an authorized agent for the purposes of these Regulations;

“quarter” means the period of three months which commences on the first day of April, the first day of July, the first day of October or the first day of January in each of the years to which the Act applies;

“the Act” means the *Sulphate of Ammonia Bounty Act 1962*.

(2.) In these Regulations, a reference to a form by number shall be read as a reference to a form so numbered in the Schedule to these Regulations.

3.—(1.) A producer may appoint a person to be his authorized agent ^{Authorized agents.} for the purposes of executing on his behalf a notice, declaration, certificate or document which the producer is required to execute by, or for the purposes of, the Act or these Regulations and the authorized agent may execute, on behalf of the producer, that notice, declaration, certificate or document.

(2.) Where a notice, declaration, certificate or document referred to in the last preceding sub-regulation has been executed by the authorized agent of a producer, the producer is subject to the same liabilities and penalties as if he had executed that notice, declaration, certificate or document.

(3.) The appointment of an authorized agent shall be—

- (a) in accordance with Form 1; and
- (b) lodged with the Collector for the State in which the producer produces sulphate of ammonia.

4. An authorization by a producer in pursuance of section 20 of the Act shall be— ^{Authorizations under section 20 of the Act.}

- (a) in accordance with Form 2; and
- (b) lodged with the Collector for the State in which the producer produces sulphate of ammonia.

5.—(1.) A producer who intends to claim bounty in respect of sulphate of ammonia shall, within one month after— ^{Notice of intention to claim bounty.}

- (a) the date of commencement of these Regulations; or
- (b) the date on which he commences to produce sulphate of ammonia,

whichever is the later, give notice of his intention to claim bounty to the Collector for the State in which he produces the sulphate of ammonia.

(2.) A notice under the last preceding sub-regulation shall be in accordance with Form 3.

6.—(1.) An application for bounty in respect of sulphate of ammonia shall be— ^{Application for bounty.}

- (a) lodged with the Collector for the State in which the sulphate of ammonia was produced within two months after the expiration of the quarter in which the sulphate of ammonia was sold for use in Australia as fertilizer, or within such further time as the Collector may, in a particular case, allow; and
- (b) accompanied by a declaration by the producer of the sulphate of ammonia.

(2.) An application and an accompanying declaration referred to in the last preceding sub-regulation shall be in accordance with Form 4.

5. That nothing on my part has been done or omitted to be done and, to the best of my knowledge and belief, nothing on the part of any other person has been done or omitted to be done, whereby the right of the producer to bounty has been forfeited or taken away.

6. That, to the best of my knowledge and belief, no other application for bounty has been made, nor has any bounty been paid or any advance under section 19 of the abovementioned Act been made, in respect of the sulphate of ammonia.
