## Atomic Energy Act 1973

No. 131 of 1973

To amend the Atomic Energy Act 1953-1966 in relation to the Executive Member of the Atomic Energy Commission.

AN ACT

[Assented to 13 November 1973]

BE IT ENACTED by the Queen, the Senate and the House of Representatives of Australia, as follows:---

1. (1) This Act may be cited as the Atomic Energy Act 1973.

(2) The Atomic Energy Act 1953-1966\* is in this Act referred to as the Principal Act.

(3) The Principal Act, as amended by this Act, may be cited as the Atomic Energy Act 1953-1973.

2. This Act shall come into operation on the day on which it receives Commencethe Royal Assent.

Constitution of the Commission. 3. Section 9 of the Principal Act is amended— (a) by omitting sub-section (1) and substituting the following sub-

section :----

"(I) The Commission shall consist of a Chairman, a Deputy Chairman and not more than three other members."; and

(b) by omitting sub-section (4).

4. Section 13 of the Principal Act is amended by omitting from Vacation of paragraph (a) of sub-section (1) the words " the Executive Member of the Commission of ".

Sections 5 (1) (definition of "Advisory Committee") and (2), 7 (2), 17 (4), 38 (3), 43 (a), 47, 50 (1), 52, 56 (3), 61 (1) and 64 (3).
