

# STATUTE LAW REVISION ACT 1974

## No. 20 of 1974

An Act for the purposes of Statute Law Revision.

BE IT ENACTED by the Queen, the Senate and the House of Representatives of Australia, as follows:—

Short title  
and citation.

1. (1) This Act may be cited as the *Statute Law Revision Act 1974*.<sup>1</sup>

(2) The *Statute Law Revision Act 1973*<sup>2</sup> is in this Act referred to as the Principal Act.

(3) The Principal Act, as amended by this Act, may be cited as the *Statute Law Revision Act 1973-1974*.

2. This Act shall be deemed to have come into operation on 31 December 1973.
