The Parliament of Australia enacts:

1 Short title

This Act may be cited as the *Customs Tariff (Fuel Rates Amendments) Act 1997*.

2 Commencement

This Act commences on the commencement of the *Excise Tariff* (Fuel Rates Amendments) Act 1997.

3 Schedule(s)

Each Act that is specified in a Schedule to this Act is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this Act has effect according to its terms.

Schedule 1—Amendment of the Customs Tariff Act 1995

1 Subsection 3(1)

marker, in relation to goods falling to Chapter 27 of Schedule 3 to this Act, means a chemical additive of a kind prescribed in the regulations made under section 5C of the *Excise Tariff Act 1921* to be a fuel marker for the purposes of that Tariff.

 - (c) a minimum kinematic viscosity of 10 centistokes (mm² per second) at 50 °C as determined by ASTM D445.

- (a) entered for home consumption under section 71A of the *Customs Act 1901*; or
- (b) delivered into home consumption in accordance with a permission granted under section 69 of that Act; or
- (c) taken into home consumption in accordance with a permission granted under section 77D of that Act;

on or after the day on which this Act commences.
