The Parliament of Australia enacts:

## **1 Short title**

This Act may be cited as the *Snowy Hydro Corporatisation  
(Consequential Amendments) Act 1997*.

## **2 Commencement**

This Act commences on the same day as section 59 of the *Snowy  
Hydro Corporatisation Act 1997*.

### **3 Schedule(s)**

**Each Act that is specified in a Schedule to this Act is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this Act has effect according to its terms.**

## **Schedule 1—Amendment of the Administrative Decisions (Judicial Review) Act 1977**

### **1 At the end of Schedule 1**

Add:

- (z) decisions of Snowy Hydro Limited or a body corporate that is a subsidiary of Snowy Hydro Limited.

### **1 The whole of the Act**

Repeal the Act.

**1 Schedule, item 21**

Repeal the item.

**1 The whole of the Act**

Repeal the Act.

### **1 Schedule**

*prescribed Commonwealth Authority*)**

Repeal the paragraph.

### **1 Section 12BA**

Repeal the section.

**1 The whole of the Act**

Repeal the Act.

## **Schedule 9—Amendment of the Superannuation Act 1976**

### **1 Subparagraph 51(2A)(a)(iv)**

Repeal the subparagraph.
