2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$18.35" and substituting "\$19.90".

Application

4. The amendments effected by these Regulations apply in relation to—
- (a) weekly payments of compensation under the *Compensation (Commonwealth Government Employees) Act 1971* in respect of any period commencing on or after 1 September 1981; and
 - (b) payments of compensation (other than weekly payments) under the *Compensation (Commonwealth Government Employees) Act 1971* in respect of—
 - (i) an injury that occurs to an employee on or after 1 September 1981; or
 - (ii) a loss or event that occurs on or after 1 September 1981 resulting from any other injury to an employee.
