2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$22.60" and substituting "\$23.55".

Application

- 4. The amendments effected by these Regulations apply in relation to—
- (a) weekly payments of compensation under the Compensation (Commonwealth Government Employees) Act 1971 in respect of any period commencing on or after 1 May 1983; and
- (b) payments of compensation (other than weekly payments) under the Compensation (Commonwealth Government Employees) Act 1971 in respect of—
 - (i) an injury that occurs to an employee on or after 1 May 1983; or
 - (ii) a loss or event that occurs on or after 1 May 1983 resulting from any other injury to an employee.
