#### Application

5. (1) An amendment of the Principal Regulations made by these Regulations, being an amendment of an amount of compensation payable at a weekly rate under the *Compensation (Commonwealth Government Employees) Act 1971*, applies in respect of compensation payable on or after 1 November 1985.

(2) An amendment of the Principal Regulations made by these Regulations, being an amendment (other than an amendment referred to in sub-regulation (1)) in respect of an amount of compensation under the Compensation (Commonwealth Government Employees) Act 1971, applies in respect of—

- (a) an injury that occurs to an employee on or after 1 November 1985; or
- (b) a loss or event that occurs on or after 1 November 1985 resulting from an injury to an employee that occurred before that date.
