Rate prescribed for the purposes of sub-section 43 (5) of the Act

1. Regulation 27 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$20.50" and substituting "\$21.20".

Rate prescribed for the purposes of sub-section 48 (1) of the Act

2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$28.70" and substituting "\$29.60".

Application

- 4. The amendments effected by these Regulations apply in relation to—
- (a) weekly payments of compensation under the Compensation (Commonwealth Government Employees) Act 1971 in respect of any period commencing after 30 April 1986; and
- (b) payments of compensation (other than weekly payments) under the Compensation (Commonwealth Government Employees) Act 1971 in respect of—
 - (i) an injury that occurs to an employee after 30 April 1986; or
 - (ii) a loss or event that occurs after 30 April 1986 resulting from any other injury to an employee.
