# **Compensation (Commonwealth Government Employees) Regulations<sup>2</sup> (Amendment)**

#### Rate prescribed for the purposes of sub-section 43 (5) of the Act

1. Regulation 27 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$21.20" and substituting "\$21.90".

# Rate prescribed for the purposes of sub-section 48(1) of the Act

2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$29.60" and substituting "\$30.50".

#### AMOUNTS OF COMPENSATION

#### Application

4. The amendments effected by these Regulations apply in relation to-

- (a) weekly payments of compensation under the Compensation (Commonwealth Government Employees) Act 1971 in respect of any period commencing after 12 December 1986; and
- (b) payments of compensation (other than weekly payments) under the Compensation (Commonwealth Government Employees) Act 1971 in respect of—
  - (i) an injury that occurs to an employee after 12 December 1986; or
  - (ii) a loss or event that occurs after 12 December 1986 resulting from any other injury to an employee.
