1. Regulation 27 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$21.90" and substituting "\$22.70".

2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$30.50" and substituting "\$31.70".

Application

- 4. The amendments effected by these Regulations apply in relation to:
- (a) weekly payments of compensation under the Compensation (Commonwealth Government Employees) Act 1971 in respect of any period commencing after 12 June 1987; and
- (b) payments of compensation (other than weekly payments) under that Act in respect of:
 - (i) an injury that occurs to an employee after 12 June 1987; or
 - (ii) a loss or event that occurs after 12 June 1987 resulting from any other injury to an employee.
