## **Compensation (Commonwealth Government Employees) Regulations<sup>2</sup> (Amendment)**

### **Rate prescribed for the purposes of subsection 43 (5) of the Act**

1. Regulation 27 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$22.70" and substituting "\$23.10".

### **Rate prescribed for the purposes of subsection 48 (1) of the Act**

2. Regulation 28 of the Compensation (Commonwealth Government Employees) Regulations is amended by omitting "\$31.70" and substituting "\$32.30".

**Application**

4. The amendments effected by these Regulations apply in relation to:
- (a) weekly payments of compensation under the *Compensation (Commonwealth Government Employees) Act 1971* in respect of any period commencing after 12 December 1987; and
  - (b) payments of compensation (other than weekly payments) under that Act in respect of:
    - (i) an injury that occurs to an employee after 12 December 1987; or
    - (ii) a loss or event that occurs after 12 December 1987 resulting from any other injury to an employee.
