## ADMINISTRATIVE ARRANGEMENTS.

ORDER BY HIS EXCELLENCY THE GOVERNOR-GENERAL.

THOMAS, BARON DENMAN, the Governor-General in and over the Common, wealth of Australia, acting with the advice of the Federal Executive Council, to hereby approve of the Administrative Arrangements specified in the Schedule into, and do order that, until further order herein, all Acts of the Commonwealth Parliament relating to the matters specified in the second column of the Schedule in the second column of the Schedule in the second column of the Department (including the Acts specified in the third column in the second column of the Department) shall, unless the contrary intention appears the Act, be administered by the Minister of State for the Commonwealth administrating that Department.
