An Act to amend the *Customs Tariff Act 1995*, and for related purposes

The Parliament of Australia enacts:

1 Short title

This Act may be cited as the *Customs Tariff Amendment (2007
Harmonized System Changes) Act 2006*.

2 Commencement

This Act commences on the day on which it receives the Royal Assent.

3 Schedule(s)
