## **An Act to make various amendments of the statute law of the Commonwealth, to repeal certain Acts and provisions of Acts, and for related purposes**

[Assented to 15 September 2011]

The Parliament of Australia enacts:

### **1 Short title**

This Act may be cited as the *Statute Stocktake Act (No. 1) 2011*.

### **2 Commencement**

This Act commences on the day after this Act receives the Royal Assent.
