- (2) The first object of this Act is to remove greenhouse gases from the atmosphere, and avoid emissions of greenhouse gases, in order to meet Australia's obligations under any or all of the following:
 - (a) the Climate Change Convention;
 - (b) the Kyoto Protocol;
 - (c) an international agreement (if any) that is the successor (whether immediate or otherwise) to the Kyoto Protocol.

Incentives

(3) The second object of this Act is to create incentives for people to carry on certain offsets projects.

Carbon abatement

- (4) The third object of this Act is to increase carbon abatement in a manner that:
 - (a) is consistent with the protection of Australia's natural environment; and
 - (b) improves resilience to the effects of climate change.

Purchase of carbon abatement by the Commonwealth

(5) The fourth object of this Act is to authorise the purchase by the Commonwealth of units that represent carbon abatement.

4 Simplified outline

The following is a simplified outline of this Act:

- This Act sets up a scheme for the issue of Australian carbon credit units in relation to eligible offsets projects.
- Australian carbon credit units and certain other types of units may be purchased by the Commonwealth.

- This Act is administered by the Clean Energy Regulator.

- (b) the Wreck Bay Aboriginal Community Council established by the *Aboriginal Land Grant (Jervis Bay Territory) Act* 1986; or
- (c) a corporation registered under the *Corporations (Aboriginal and Torres Strait Islander) Act 2006*; or
- (d) an authority or body that is:
 - (i) established by or under a law of the Commonwealth, a State or a Territory; and
 - (ii) specified in the regulations or the legislative rules.

Torrens system land: land is **Torrens system land** if the title to the land is registered under a Torrens system of registration.

Torres Strait Islander has the same meaning as in the *Native Title Act 1993*.

transfer, in relation to an Australian carbon credit unit, has the meaning given by section 151.

trust means a person in the capacity of trustee or, as the case requires, a trust estate.

7 Electronic notice transmitted to the Regulator

- (2) The regulations or legislative rules may make provision for or in relation to the security and authenticity of notices transmitted to the Regulator by means of an electronic communication.

- (4) Subsection (3) does not limit subsection (2).

7A Extended accounting period

9B Application to foreign ships

This Act does not apply to the extent that its application would be inconsistent with the exercise of rights of foreign ships in:

- (a) the territorial sea; or
- (b) the exclusive economic zone; or

- (5) The Regulator must not issue an Australian carbon credit unit to a person in accordance with subsection (2) or (3) unless the person has a Registry account.

 - (ea) if:
 - (i) under the legislative rules, a set of 2 or more applications made by the applicant is subject to audit under this Act; and
 - (ii) the application is included in that set; be accompanied by an audit report that is:
 - (iii) prescribed by the legislative rules; and

- (e) if the relevant section 27 declaration is subject to the condition that all regulatory approvals must be obtained for the project before the end of the first reporting period for the project—that condition has been met; and

 - (f) the applicant is not subject to a requirement under Part 7 to relinquish a number of Australian carbon credit units; and
- (g) no amount is payable by the applicant under:
 - (i) section 179; or
 - (ii) section 180;
 - in relation to a requirement under Part 7 to relinquish a number of Australian carbon credit units; and
- (h) if the regulations or the legislative rules specify one or more other eligibility requirements—those requirements are met; the Regulator must issue a certificate of entitlement in respect of the project for the period.
- Note 1: For the fit and proper person test, see section 60.
- Note 2: For the no double counting test, see section 15A.
- (3) A certificate of entitlement must state that a specified number is the unit entitlement in respect of the certificate.
 - Note: For unit entitlement, see section 16 or 18.
- (4) If the application sets out the account number of a Registry account of the applicant that should be specified in the certificate of entitlement, the certificate must specify that account number.

Timing

Part 2A—Purchase of eligible carbon credit units by the Commonwealth

Division 2—Carbon abatement contracts

20B Carbon abatement contracts

- (1) The functions of the Regulator include entering into contracts, on behalf of the Commonwealth, for the purchase by the Commonwealth of eligible carbon credit units.
- (2) It is immaterial whether the units are in existence when the contract is entered into.
- (3) For the purposes of this Act, a contract entered into under subsection (1) is to be known as a *carbon abatement contract*.
- (4) For the purposes of this Act, if the Regulator enters into a carbon abatement contract with a person, the person is a *carbon abatement contractor*.

20C When carbon abatement contracts may be entered into

- (1) The Regulator may enter into a carbon abatement contract under section 20B as the result of a carbon abatement purchasing process conducted by the Regulator under section 20G.
- (2) The Regulator must not enter into a carbon abatement contract under section 20B unless the carbon abatement contractor for the contract is a project proponent for an eligible offsets project.

 - (c) the Regulator may institute an action or proceeding on behalf of the Commonwealth in relation to a matter that concerns a carbon abatement contract.

20E Conferral of powers on the Regulator

20G Conduct of carbon abatement purchasing processes

 - (d) be conducted in a manner that ensures the integrity of the process; and

- (e) encourage competition; and
- (f) provide for fair and ethical treatment of all participants in the process.
- (4) To avoid doubt, the mere fact that a person is a project proponent for an eligible offsets project does not automatically entitle the person to participate in a carbon abatement purchasing process.

Division 4—Miscellaneous

20H Legislative rules may provide for certain matters relating to purchased eligible carbon credit units etc.

- (1) The legislative rules may make provision for and in relation to any or all of the following matters in respect of eligible carbon credit units purchased by the Commonwealth under carbon abatement contracts:
 - (a) transferring purchased units to a specified Commonwealth Registry account;
 - (b) prohibiting or restricting the transfer of units from such an account;
 - (c) cancelling units for which there are entries in such an account.

Note: For designation of Commonwealth Registry accounts, see section 12 of the Australian National Registry of Emissions Units Act 2011.

Restoration of units that were transferred by mistake

- (2) If:
 - (a) one or more eligible carbon credit units were transferred from a Registry account kept by a person to a Commonwealth Registry account specified in legislative rules made for the purposes of paragraph (1)(a); and
 - (b) the units have been cancelled; and
 - (c) the Regulator is satisfied that the units were transferred by mistake;

then:

- (d) the Regulator must, by written notice given to the person, determine that the units that were transferred are *restored units* for the purposes of this section; and
- (e) a restored unit is taken never to have been cancelled; and
- (f) the Regulator must make an entry for a restored unit in a Registry account kept by the person.

 - (i) the project is an area-based offsets project; and
 - (ii) the project area, or any of the project areas, for the project is covered by a regional natural resource management plan;

- (cc) if a notice under section 77A is relevant to the offsets report—be accompanied by a copy of that notice; and
- (d) be accompanied by such other documents (if any) as are specified in the regulations or the legislative rules; and
- (e) be given to the Regulator within:
 - (i) 6 months after the end of the reporting period; or
 - (ii) if a greater number of months is specified in the applicable methodology determination for the project that greater number of months after the end of the reporting period.
- (5) The Regulator must not give a notice under paragraph (4)(cb) unless the Regulator is satisfied that it is appropriate to do so, having regard to effective risk management.

- (b) there has been a reduction below the benchmark sequestration level of the sequestration of carbon in the relevant carbon pool on the area or areas;

the owner or occupier of the land must take all reasonable steps to ensure that the number of tonnes of carbon sequestered in the relevant carbon pool on the area or areas is not less than the benchmark sequestration level.

Ancillary contraventions

- (11) A person must not:
 - (a) aid, abet, counsel or procure a contravention of subsection (9) or (10); or
 - (b) induce, whether by threats or promises or otherwise, a contravention of subsection (9) or (10); or
 - (c) be in any way, directly or indirectly, knowingly concerned in, or party to, a contravention of subsection (9) or (10); or
 - (d) conspire with others to effect a contravention of subsection (9) or (10).

Civil penalty provisions

(12) Subsections (9), (10) and (11) are *civil penalty provisions*.

Note: Part 21 provides for pecuniary penalties for breaches of civil penalty provisions.

Duration of declaration

- (13) A declaration under subsection (2) comes into force when a copy of the declaration is given to the project proponent for the project under subsection (6).
- (14) Unless sooner revoked, a declaration under subsection (2) ceases to be in force at whichever of the following times happens first:

 - (i) the notice referred to in subparagraph (1)(c)(ii) is given; and
 - (ii) the notice required a person to relinquish a particular number of Australian carbon credit units; and

 - (d) the relevant land registration official.
- (5) A failure to comply with subsection (4) does not affect the validity of a variation or revocation.

Refusal

(6) If the Regulator decides to refuse to revoke the declaration, the Regulator must give written notice of the decision to the applicant.

Revocation is not a legislative instrument

(7) A revocation of the declaration is not a legislative instrument.

Division 3—Injunctions

100 Injunctions

Performance injunctions

- (1) If:
 - (a) a person has refused or failed, or is refusing or failing, or is proposing to refuse or fail, to do an act or thing; and
 - (b) the refusal or failure was, is or would be a contravention of subsection 97(9) or (10);

the Federal Court may, on the application of the Regulator, grant an injunction requiring the person to do that act or thing.

Restraining injunctions

- (2) If a person has engaged, is engaging or is proposing to engage, in any conduct in contravention of subsection 97(9) or (10), the Federal Court may, on the application of the Regulator, grant an injunction:
 - (a) restraining the person from engaging in the conduct; and
 - (b) if, in the Court's opinion, it is desirable to do so—requiring the person to do something.

101 Interim injunctions

Grant of interim injunction

(1) If an application is made to the Federal Court for an injunction under section 100, the Court may, before considering the application, grant an interim injunction restraining a person from engaging in conduct of a kind referred to in that section.

 - (b) if it appears to the Court that, if an injunction is not granted, it is likely that the person will engage in conduct of that

The following is a simplified outline of this Part:

- The Minister may make or vary a methodology determination that applies to a specified kind of offsets project.
 - Before making or varying a methodology determination, the Minister must request the Emissions Reduction Assurance Committee to advise on the proposed determination or variation.
- In making or varying a methodology determination, the Minister must have regard to:
 - (a) advice given by the Emissions Reduction Assurance Committee; and
 - (b) the offsets integrity standards; and
 - (c) certain other matters.

Division 2—Methodology determinations

Subdivision A—Making of methodology determinations

106 Methodology determinations

- (1) The Minister may, by legislative instrument, make a determination that:
 - (a) is expressed to apply to a specified kind of offsets project; and
 - (b) sets out requirements that must be met for such a project to be an eligible offsets project; and
 - (c) provides that, if such a project is an eligible offsets project, the carbon dioxide equivalent net abatement amount for the project in relation to a reporting period for the project is taken, for the purposes of this Act, to be equal to the amount ascertained using a method specified in, or ascertained in accordance with, the determination.
 - Note 1: For declarations of eligible offsets projects, see section 27.
 - Note 2: See also subsection 27(4A) in relation to certain additionality requirements that may be specified in a methodology determination.
 - Note 3: See also sections 69, 70 and 71 in relation to specifying a crediting period in a methodology determination.
 - Note 4: See also paragraph 76(4)(e) in relation to specifying in a methodology determination the deadline for giving an offsets report.
 - Note 5: See also subsection 77A(2) in relation to setting out in a methodology determination requirements relating to the division of an offsets project into 2 or more parts.
- (2) A determination under subsection (1) is to be known as a *methodology determination*.
- (3) A methodology determination that applies to a particular kind of offsets project may provide that, if such a project is an eligible offsets project, the project proponent for the project is subject to any or all of the following requirements:

- (a) specified requirements to include specified information relating to the project in each offsets report about the project;
- (b) specified requirements to notify one or more matters relating to the project to the Regulator;
- (c) specified record-keeping requirements relating to the project;

- (4) In deciding whether to make a methodology determination, the Minister must have regard to the following:
 - (a) whether the determination complies with the offsets integrity standards:
 - (b) any advice that the Emissions Reduction Assurance Committee has given to the Minister under subsection 123A(2) in relation to the making of the determination;
 - (c) whether any adverse environmental, economic or social impacts are likely to arise from the carrying out of the kind of project to which the determination applies;
 - (d) such other matters (if any) as the Minister considers relevant.
- (4A) The Minister must not make a methodology determination unless a method specified in, or ascertained in accordance with, the determination in accordance with paragraph (1)(c) provides that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project is eligible carbon abatement from the project.
- (4B) The Minister must not make a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the determination does not comply with one or more of the offsets integrity standards.
 - (7) Paragraph (1)(a) of this section does not, by implication, affect the application of subsection 13(3) of the *Legislation Act 2003* to another instrument under this Act.

- (8) A methodology determination may make provision in relation to a matter by applying, adopting or incorporating, with or without modification, a matter contained in an instrument or writing:

 - Note 2: For variations of a minor nature, see subsection (9).
 - (7) In deciding whether to vary a methodology determination, the Minister must have regard to the following:
 - (a) any relevant advice given by the Emissions Reduction Assurance Committee under subsection 123A(2);

- (7A) The Minister must not vary a methodology determination so as to extend the crediting periods for the eligible offsets projects covered by the determination unless:
 - (a) the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should be made; and
 - (b) the Emissions Reduction Assurance Committee has not previously advised the Minister under subsection 123A(2) or paragraph 255(hc) that the variation should not be made; and
 - (c) the determination has not previously been varied so as to extend the crediting periods.
- (7B) The Minister must not vary a methodology determination if the Emissions Reduction Assurance Committee has advised the Minister under subsection 123A(2) that the varied determination does not comply with one or more of the offsets integrity standards.

 - (a) to vary a methodology determination; or
 - (b) not to vary a methodology determination;

Subdivision C—Duration of methodology determinations

122 Duration of methodology determinations

Committee must have regard to certain matters

- (5) In giving the requested advice to the Minister, the Emissions Reduction Assurance Committee must have regard to the following:
 - (a) the offsets integrity standards;
 - (b) any relevant matters specified in a direction in force under section 123B;
 - (c) any relevant advice given by the Regulator to the Committee.
- (6) Subsection (5) does not, by implication, limit the matters to which the Emissions Reduction Assurance Committee may have regard.

123B Additional matters for the Emissions Reduction Assurance Committee to take into account

The Minister may, by legislative instrument, direct the Emissions Reduction Assurance Committee to do any or all of the following:

 - (i) if the Minister were to make a proposed methodology determination, the determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c); or
 - (ii) if the Minister were to make a particular variation of a methodology determination, the varied determination would not comply with the offsets integrity standard set out in paragraph 133(1)(c);

then, in giving relevant advice to the Minister under subsection 123A(2), the Emissions Reduction Assurance Committee is to assume that the determination or varied determination, as the case may be, would not comply with that offsets integrity standard.

123D Consultation by the Emissions Reduction Assurance Committee

- (1) The Emissions Reduction Assurance Committee must not advise the Minister to make or vary a methodology determination unless the Committee has first:
 - (a) published on the Department's website:
 - (i) a detailed outline of the proposed determination or variation, as the case may be; and
 - (ii) a notice inviting the public to make a submission to the Committee on the detailed outline by a specified time limit; and
 - (b) considered any submissions that were received within that time limit.
- (2) The time limit must be 28 days after the notice is published.
- (3) However, the time limit may be shorter than 28 days after the notice is published, so long as:
 - (a) the Emissions Reduction Assurance Committee considers that the time limit is appropriate in the circumstances; and

Publication of submissions

Subdivision E—Applicable methodology determination

124 Applicable methodology determination for a reporting period

For the purposes of this Act, if a methodology determination applies to an eligible offsets project throughout a reporting period for the project, the determination is the applicable methodology determination for the reporting period.

124A Modified meaning of *crediting period* for an emissions avoidance offsets project that has an extended accounting period

This Subdivision has effect, in relation to an emissions avoidance offsets project that has an extended accounting period that begins immediately after the end of a crediting period, as if a reference in this Subdivision (other than this section) to the crediting period were a reference to the period:

- (a) beginning at the start of the crediting period; and
- (b) ending at the end of the extended accounting period.

133 Offsets integrity standards

 - (i) the removal of one or more greenhouse gases from the atmosphere;
 - (ii) the reduction of emissions of one or more greenhouse gases into the atmosphere;
 - (iii) the emission of one or more greenhouse gases into the atmosphere;

the removal, reduction or emission, as the case may be, should be:

- (iv) measurable; and
- (v) capable of being verified;
- (c) a method specified in, or ascertained in accordance with, a methodology determination in accordance with paragraph 106(1)(c) should provide that carbon abatement used in ascertaining the carbon dioxide equivalent net abatement amount for a project must be eligible carbon abatement from the project;

(4) The Minister may, by legislative instrument, make a determination providing that a specified estimate, projection or assumption is taken to be conservative for the purposes of this section.

- (3) The multiple project proponents are not entitled to take an eligible voluntary action except in accordance with subsection (2).

Division 2—Issue of Australian carbon credit units

147 Issue of Australian carbon credit units

The Regulator may, on behalf of the Commonwealth, issue units, to be known as Australian carbon credit units.

148 How Australian carbon credit units are to be issued

- (1) The Regulator is to issue an Australian carbon credit unit to a person by making an entry for the unit in a Registry account kept by the person.
- (2) The Regulator must not issue an Australian carbon credit unit to a person unless the person has a Registry account.

149 Circumstances in which Australian carbon credit units may be issued

The Regulator must not issue an Australian carbon credit unit otherwise than in accordance with Part 2.

Division 3—Property in, and transfer of, Australian carbon credit units

150 An Australian carbon credit unit is personal property

An Australian carbon credit unit is personal property and, subject to sections 152 and 153, is transmissible by assignment, by will and by devolution by operation of law.

150A Ownership of Australian carbon credit unit

- (1) The registered holder of an Australian carbon credit unit:
 - (a) is the legal owner of the unit; and
 - (b) may, subject to this Act and the *Australian National Registry* of *Emissions Units Act 2011*, deal with the unit as its legal owner and give good discharges for any consideration for any such dealing.
- (2) Subsection (1) only protects a person who deals with the registered holder of the unit as a purchaser:
 - (a) in good faith for value; and
 - (b) without notice of any defect in the title of the registered holder.

151 Transfer of Australian carbon credit units

For the purposes of this Act, if there is an entry for an Australian carbon credit unit in a Registry account (the *first Registry account*) kept by a person (the *first person*):

- (a) a *transfer* of the unit from the first Registry account to a Registry account kept by another person consists of:
 - (i) the removal of the entry for the unit from the first Registry account; and
 - (ii) the making of an entry for the unit in the Registry account kept by the other person; and

- (1) A transmission by assignment of an Australian carbon credit unit for which there is an entry in a Registry account is of no force until:

 - (b) the Regulator complies with that instruction.

 - (d) give the Regulator a copy of the audit report on or before the day specified in the notice.

(3) The notice must specify:

256 Membership of the Emissions Reduction Assurance Committee

The Emissions Reduction Assurance Committee consists of the following members:

- (a) a Chair;
- (b) at least 4, and not more than 8, other members.

257 Appointment of Emissions Reduction Assurance Committee members

(1) Each Emissions Reduction Assurance Committee member is to be appointed by the Minister by written instrument.

Note: An Emissions Reduction Assurance Committee member is eligible for reappointment: see the *Acts Interpretation Act 1901*.

- (2) A person is not eligible for appointment as an Emissions Reduction Assurance Committee member unless the Minister is satisfied that the person has:
 - (a) substantial experience or knowledge; and
 - (b) significant standing;

in at least one field of expertise that is relevant to the functions of the Emissions Reduction Assurance Committee.

- (3) The Minister must ensure that the Chair of the Emissions Reduction Assurance Committee is not a person covered by subsection (4).
- (4) This subsection applies to the following persons:
 - (a) an employee of the Commonwealth;
 - (b) an employee of an authority of the Commonwealth;
 - (c) a person who holds a full-time office under a law of the Commonwealth.

258 Period for appointment for Emissions Reduction Assurance Committee members

An Emissions Reduction Assurance Committee member holds office for the period specified in the instrument of appointment. The period must not exceed 5 years.

- (2) A resolution is taken to have been passed at a meeting of the Emissions Reduction Assurance Committee if:
 - (a) without meeting, a majority of Emissions Reduction Assurance Committee members indicate agreement with the resolution in accordance with the method determined by the Emissions Reduction Assurance Committee under subsection (3); and
 - (b) all Emissions Reduction Assurance Committee members were informed of the proposed resolution, or reasonable efforts had been made to inform all Emissions Reduction Assurance Committee members of the proposed resolution.
- (3) Subsection (2) applies only if the Emissions Reduction Assurance Committee:
 - (a) determines that it applies; and
 - (b) determines the method by which Emissions Reduction Assurance Committee members are to indicate agreement with resolutions.
- (4) If an Emissions Reduction Assurance Committee member is an APS employee in the Department, the member:
 - (a) is not entitled to vote for a resolution at a meeting of the Emissions Reduction Assurance Committee; and
 - (b) is not entitled to indicate agreement with a resolution as mentioned in paragraph (2)(a); and

- (c) is not to be counted for the purposes of determining whether a majority of Emissions Reduction Assurance Committee members:

261 Disclosure of interests to the Minister

An Emissions Reduction Assurance Committee member must give written notice to the Minister of all interests, pecuniary or otherwise, that the member has or acquires and that conflict or could conflict with the proper performance of the member's functions.

262 Disclosure of interests to Emissions Reduction Assurance Committee

- (1) An Emissions Reduction Assurance Committee member who has an interest, pecuniary or otherwise, in a matter being considered or about to be considered by the Emissions Reduction Assurance Committee must disclose the nature of the interest to a meeting of the Emissions Reduction Assurance Committee.
- (2) The disclosure must be made as soon as possible after the relevant facts have come to the Emissions Reduction Assurance Committee member's knowledge.
- (3) The disclosure must be recorded in the minutes of the meeting of the Emissions Reduction Assurance Committee.
- (4) Unless the Emissions Reduction Assurance Committee otherwise determines, the Emissions Reduction Assurance Committee member:
 - (a) must not be present during any deliberation by the Emissions Reduction Assurance Committee on the matter; and

- (b) must not take part in any decision of the Emissions Reduction Assurance Committee with respect to the matter.
- (5) For the purposes of making a determination under subsection (4), the Emissions Reduction Assurance Committee member:
 - (a) must not be present during any deliberation of the Emissions Reduction Assurance Committee for the purpose of making the determination; and
 - (b) must not take part in making the determination.
- (6) A determination under subsection (4) must be recorded in the minutes of the meeting of the Emissions Reduction Assurance Committee.

263 Outside employment

An Emissions Reduction Assurance Committee member must not engage in any paid employment that conflicts or may conflict with the proper performance of his or her duties.

264 Remuneration and allowances

- (1) An Emissions Reduction Assurance Committee member is to be paid the remuneration that is determined by the Remuneration Tribunal. If no determination of that remuneration by the Tribunal is in operation, the member is to be paid the remuneration that is prescribed.
- (2) An Emissions Reduction Assurance Committee member is to be paid the allowances that are prescribed.
- (3) This section has effect subject to the *Remuneration Tribunal Act* 1973.

265 Leave of absence

(1) The Minister may grant leave of absence to the Chair of the Emissions Reduction Assurance Committee on the terms and conditions that the Minister determines.

 - (a) an employee of the Commonwealth; or

268 Other terms and conditions

An Emissions Reduction Assurance Committee member holds office on the terms and conditions (if any) in relation to matters not covered by this Act that are determined by the Minister.

269 Assistance to Emissions Reduction Assurance Committee

- (1) Any or all of the following bodies:
 - (a) the Regulator;
 - (b) the Department;
 - (c) any other Department, agency or authority of the Commonwealth;

Part 27—Secrecy

270 Secrecy

- (1) A person commits an offence if:
 - (a) the person is, or has been, an entrusted public official; and
 - (b) the person has obtained protected information in his or her capacity as an entrusted public official; and
 - (c) the person:
 - (i) discloses the information to another person; or
 - (ii) uses the information.

Penalty: Imprisonment for 2 years or 120 penalty units, or both.

Exceptions

- (2) Each of the following is an exception to the prohibition in subsection (1):
 - (a) the disclosure or use is authorised by a provision of this Part;
 - (b) the disclosure or use is in compliance with a requirement under:
 - (i) a law of the Commonwealth; or
 - (ii) a prescribed law of a State or a Territory.

Note: A defendant bears an evidential burden in relation to a matter in subsection (2) (see subsection 13.3(3) of the *Criminal Code*).

- (3) Except where it is necessary to do so for the purposes of giving effect to this Act or a legislative instrument under this Act, an entrusted public official is not to be required:
 - (a) to produce to a court or tribunal a document containing protected information; or
 - (b) to disclose protected information to a court or tribunal.

- (1) An entrusted public official may disclose protected information to a Royal Commission.

 - (g) a person assisting an audit team leader.
- (3) The Chair of the Emissions Reduction Assurance Committee may, by writing, impose conditions to be complied with in relation to protected ERAC information disclosed under subsection (1) by:
 - (a) the Chair; or
 - (b) an Emissions Reduction Assurance Committee member; or
 - (c) a person assisting the Emissions Reduction Assurance Committee under section 269.
- (4) An instrument under subsection (2) or (3) is not a legislative instrument.

- (g) to advise and assist the representatives of persons in relation to compliance by persons with this Act and the associated provisions;
- (h) to liaise with regulatory and other relevant bodies, whether in Australia or elsewhere, about co-operative arrangements for matters relating to this Act and the associated provisions;
- (i) to collect, analyse, interpret and disseminate statistical information relating to the operation of this Act and the associated provisions.

287 Computerised decision-making

(1) The Regulator may, by legislative instrument, arrange for the use, under the Regulator's control, of computer programs for any
