## An Act to repeal certain Acts, and for related purposes

[Assented to 12 November 2015]

The Parliament of Australia enacts:

### 1 Short title

This Act may be cited as the *Amending Acts 1980 to 1989 Repeal Act 2015*.

## 2 Commencement

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

## 3 Repeals of Acts
