The Parliament of Australia enacts:

1 Short title

This Act may be cited as the *Biological Control Amendment Act* 2016.

2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with

Schedule 1—Amendments

Biological Control Act 1984

1 Subsection 2(1) (definition of *kind*)

After "organisms", insert ", viruses or sub-viral agents".

2 Subsection 2(1) (at the end of the definition of *organism*)

Add:

; or (c) a virus or a sub-viral agent.

3 Subsection 2(1) (definition of *prescribed live organisms*) Repeal the definition.

4 Subsection 2(1)

Insert:

prescribed organisms means organisms that are:

- (a) live organisms; or
- (b) viruses or sub-viral agents;

but does not include live vaccines or resistant cultivars.

5 Section 3

Omit "live", substitute "prescribed".

6 Subsections 21(1), 22(1) and 26(1)

Omit "live".

7 Paragraphs 30(1)(b), 31(1)(a) and 34(2)(a)

Omit "live".

8 Subsection 37(3)

Omit "live".

9 Declarations of relevant State laws

If:
