## **An Act to amend the *Passenger Movement Charge Act 1978*, and for related purposes**

[Assented to 23 March 2016]

The Parliament of Australia enacts:

### **1 Short title**

This Act may be cited as the *Passenger Movement Charge Amendment (Norfolk Island) Act 2016*.

## 2 Commencement

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

2. Schedule 1	At the same time as Schedule 5 to the <i>Territories Legislation Amendment Act 2016</i> commences.  However, the provisions do not commence at all if that Schedule does not commence.	1 July 2016

- (2) Any information in column 3 of the table is not part of this Act. Information may be inserted in this column, or information in it may be edited, in any published version of this Act.

## 3 Schedules

Legislation that is specified in a Schedule to this Act is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this Act has effect according to its terms.

## **Schedule 1—Amendments**

### ***Passenger Movement Charge Act 1978***

#### **1 Section 3 (definition of *Australia*)**

Repeal the definition.

#### **2 Paragraph 4(3)(a)**

After “departs from”, insert “Norfolk Island or”.

#### **3 Paragraph 4(3)(b)**

Omit “Indian Ocean”.

#### **4 Paragraph 4(4)(a)**

After “other than”, insert “Norfolk Island or”.

#### **5 Paragraph 4(4)(b)**

After “Joint Petroleum Development Area, for”, insert “Norfolk Island or”.
