The Parliament of Australia enacts:

#### 1 Short title

This Act is the Narcotic Drugs (Licence Charges) Act 2016.

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

### 3 Definitions

In this Act:

charge means charge imposed by this Act.

*licence* means a licence granted under the *Narcotic Drugs Act* 1967.

#### 4 Crown to be bound

This Act binds the Crown in each of its capacities. However, it does not bind the Crown in right of the Commonwealth.

#### 5 Extension to external Territories

This Act extends to every external Territory.

## 6 Imposition of charge

- (1) Charge is imposed on a licence that is in force at whichever of the following times is applicable:
  - (a) any time during a financial year;
  - (b) any time during such other period as is prescribed by the regulations.
- (2) Without limiting subsection (1), the regulations may prescribe different periods in relation to the following:
  - (a) different classes of licence;
  - (b) licences of the same class that authorise different activities.

## 7 By whom charge payable

Charge imposed on a licence is payable by the holder of the licence.

### 8 Amount of charge

- (1) The amount of the charge for a period is such amount as is prescribed by the regulations.
- (2) Without limiting subsection (1), the regulations may prescribe different charges in relation to the following:
  - (a) different classes of licence;
  - (b) licences of the same class that authorise different activities.
- (3) In this section:

amount includes a nil amount.

# 9 Regulations

The Governor-General may make regulations prescribing matters:

- (a) required or permitted by this Act to be prescribed; or
- (b) necessary or convenient to be prescribed for carrying out or giving effect to this Act.
