## An Act to amend the *Farm Household Support Act 2014*, and for related purposes

The Parliament of Australia enacts:

### 1 Short title

This Act is the *Farm Household Support Amendment Act 2018*.

### 2 Commencement

Omit “3 years or less”, substitute “4 years or less”.

#### **7 Subsection 6(3)**

Omit “3 years or less”, substitute “4 years or less”.

#### **8 Subsection 6(3)**

Omit “1095 days”, substitute “1,460 days”.

#### **9 Section 7**

Omit “3 years”, substitute “4 years”.

#### **10 Paragraph 8(h)**

Omit “3 years”, substitute “4 years”.

**11 Paragraph 9(j)**

Omit “3 years”, substitute “4 years”.

**12 Subsections 96(1) and (2)**

Omit “3 years”, substitute “4 years”.

**13 Application of amendments**

The amendments made by this Schedule apply in relation to the following:

- (a) a person who made a claim for farm household allowance at any time before the day this Schedule commences (whether or not the claim had been determined before that day);
- (b) a person who makes a claim for farm household allowance on or after the day this Schedule commences.
