1 Authorising provision

This Notice is made under:

- a) Section 174 of the Heavy Vehicle National Law as applied in each participating jurisdiction.
- b) Section 18 of the Heavy Vehicle National (Mass, Dimension and Loading) National Regulation as applied in each participating jurisdiction.

2 Purpose

The purpose of this Notice is to amend stated maps for vehicles at the request of road managers.

3 Commencement Date

The amendments take effect 28 days after publication of Amendment Notice 2020 (No.4)

4 Title

This Notice may be cited as the Heavy Vehicle Stated Maps – Amendment Notice 2020 (No.4)

5 Application

This Notice applies in all participating jurisdictions.

6 Amendments

The specified networks in Column 2 of Schedule 1 to this Notice are amended as specified in Column 4 for the Road Manager's reasons shown in Column 5.
