The Parliament of Australia enacts:

#### 1 Short title

This Act is the Federal Courts Legislation Amendment (Judicial Immunity) Act 2023.

#### 2 Commencement

(1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

#### Federal Circuit and Family Court of Australia Act 2021

#### 2 Subsections 169(5) and 170(5)

Omit "Judge of the Federal Circuit and Family Court of Australia (Division 2)", substitute "Judge of the Federal Court".

#### **3 Subsection 257(1)**

Omit "Judge of the Court", substitute "Judge of the Federal Circuit and Family Court of Australia (Division 1)".

#### 4 At the end of Chapter 4

Add:

#### Part 10—Miscellaneous

### 277A Immunity for Judges of Federal Circuit and Family Court of Australia (Division 2)

A Judge of the Federal Circuit and Family Court of Australia (Division 2) has the same protection and immunity as a Judge of the Federal Circuit and Family Court of Australia (Division 1).

#### 5 Application of amendments

The amendments made by this Schedule apply in relation to functions performed on or after the day this Schedule commences.
