| 1. These Regulations may be cited as the Ombudsman Regulations. | Citation. |
| 2. These Regulations shall come into operation on 1 July 1977. | Commencement. |
| 3. In these Regulations, "the Act" means the <i>Ombudsman Act 1976</i> . | Interpretation. |
| 4. For the purposes of the definition of "prescribed authority" in section 3 of the Act, a body specified in Schedule 1 is not to be taken to be a prescribed authority for the purposes of the Act. | Bodies not to be taken to be prescribed authorities for the purposes of the Act. |
| 5. For the purposes of the definition of "prescribed authority" in section 3 of the Act, each of the bodies specified in Schedule 2 is declared to be a prescribed authority for the purposes of the Act. | Prescribed authorities. |
| 6. For the purposes of the definition of "prescribed authority" in section 3 of the Act, a person holding, or performing the duties of, an office specified in Schedule 3 is not to be taken to be a prescribed authority for the purposes of the Act. | Persons not to be taken to be prescribed authorities for the purposes of the Act. |
