## Australian Citizenship Regulations<sup>2</sup> (Amendment)

I, THE GOVERNOR-GENERAL of the Commonwealth of Australia, acting  
with the advice of the Federal Executive Council, hereby make the following  
Regulations under the *Australian Citizenship Act 1948*.

### Commencement

1. These Regulations shall come into operation on 1 October 1984.

### Principal Regulations

2. In these Regulations, "Principal Regulations" means the Australian  
Citizenship Regulations.

3. Regulations 10 and 10A of the Principal Regulations are repealed and  
the following regulation is substituted:

### Certificate of Australian citizenship

"10. (1) Subject to sub-regulation (2), a certificate of Australian  
citizenship granted under section 14 of the Act shall be in accordance with  
Form 6.

“(2) Where the name of a child is, under sub-section 14 (9) of the Act, included in a certificate of Australian citizenship, the certificate shall be in accordance with Form 7.

“(3) A certificate of Australian citizenship granted under section 32 of the Act shall be in accordance with Form 8.”.

#### **Issue of certificate of Australian citizenship**

4. Regulation 12 of the Principal Regulations is amended by omitting sub-regulation (2).

#### **Repeal of regulation 19**

5. Regulation 19 of the Principal Regulations is repealed.

#### **Second Schedule**

6. The Second Schedule to the Principal Regulations is amended by omitting Forms 6, 7 and 8 and substituting the following forms:
