88A Allowances payable to Executive Director (Act s 18AL)

- (1) This regulation applies to the Executive Director only if his or her employment in that office is not subject to an Australian workplace agreement or a certified agreement.
- (2) For subsection 18AL (2) of the Act, the allowances payable to the Executive Director are the allowances (other than travelling allowances) payable to a Senior Executive Service officer whose employment is not subject to an Australian workplace agreement or a certified agreement.
- (3) In this regulation:

Australian workplace agreement has the same meaning as in the *Workplace Relations Act 1996*.

certified agreement has the same meaning as in the *Workplace Relations Act 1996*.

Senior Executive Service officer has the same meaning as in the *Public Service Act 1922*.
