



# Superannuation Guarantee (Administration) Amendment Regulations 2005 (No. 2)<sup>1</sup>

**1 Name of Regulations**

These Regulations are the *Superannuation Guarantee (Administration) Amendment Regulations 2005 (No. 2)*.

**2 Commencement**

These Regulations commence as follows:

- (a) on 1 July 2005 — regulations 1 to 3 and Schedule 1;
- (b) on 1 July 2006 — Schedule 2.

**3 Amendment of *Superannuation Guarantee (Administration) Regulations 1993***

- (1) Schedule 1 amends the *Superannuation Guarantee (Administration) Regulations 1993*, as amended by the *Superannuation Guarantee (Administration) Amendment Regulations 2005 (No. 1)*.

*Note* The *Superannuation Guarantee (Administration) Amendment Regulations 2005 (No. 1)* are Select Legislative Instrument 2005 No. 25.

- (2) Schedule 2 amends the *Superannuation Guarantee (Administration) Regulations 1993*.

## Schedule 1      Amendments commencing on 1 July 2005
