An Ordinance to amend the *Applied Laws (Implementation) Ordinance 1992*

1. Short title

1.1 This Ordinance may be cited as the *Applied Laws (Implementation) (Amendment) Ordinance 1993*.¹

2. Commencement

2.1 This Ordinance commences on 1 July 1993.

3. Amendment

3.1 The *Applied Laws (Implementation) Ordinance 1992*² is amended as set out in this Ordinance.

4. Section 4 (Suspension of provisions of applied laws)

4.1 Omit the section, substitute:

Suspension of provisions of applied laws

“4. A provision specified in Schedule 2 of an applied law specified in that Schedule is suspended until 1 January 1994.”.

5. Section 5 (Suspension of applied laws)

5.1 Omit “1 July 1993”, substitute “1 January 1994”.

6. Schedule 2 (Suspension of provisions of applied laws)

6.1 Omit the Schedule, substitute:
