1. Name of Order

This Order is the *Australian Meat and Live-stock Industry (Standards) Amendment Order 2006 (No. 2)*.

2. Commencement

This Order commences on 25 September 2006.

3. Revocation of *Australian Meat and Live-stock Industry (Standards) Amendment Order 2006 (No. 1)*

This Order revokes the *Australian Meat and Live-stock Industry (Standards) Amendment Order 2006 (No. 1)*.

4. Amendments of *Australian Meat and Live-stock Industry (Standards) Order 2005*

Schedule 1 amends the *Australian Meat and Live-stock Industry (Standards) Order 2005*.

5. Application of amendment

- (1) Subject to subsections (2) and (3), the amendment made by item 1 of Schedule 1 applies in relation to exports of live-stock from Australia on or after 25 September 2006.
- (2) The requirement contained in the Note to subparagraph (c)(i) of Standard S1.9 of the *Australian Standards for the Export of Livestock* (Version 2, September 2006) does not apply to cattle and buffalo from the Northern Territory sourced for export as slaughter or feeder animals until 1 January 2007.
- (3) For the period 25 September 2006 to 31 December 2006, the requirement contained in the Note at the end of Standard S1.9 of the *Australian Standards for the Export of Live-stock* published by the Department, as in force on 1 July 2005, applies to cattle and buffalo from the Northern Territory sourced for export as slaughter or feeder animals.
