## 1 Name of Regulations

These Regulations are the *Health Insurance (General Medical Services Table) Amendment Regulations 2007 (No. 3).* 

#### 2 Commencement

These Regulations commence:

- (a) if they are registered before the *Private Health Insurance*Act 2007 commences on the commencement of that Act; or
- (b) if they are registered after that Act commences on the day after they are registered.
