

FMA Act Determination 2008/07 — Section 32 (Transfer of Functions from AGD to PM&C)

Financial Management and Accountability Act 1997

I, Tim Youngberry, Division Manager, Financial Reporting and Cash Management Division, Department of Finance and Deregulation, make this Determination under subsection 32 (2) of the *Financial Management and Accountability Act 1997* (the *FMA Act*).

1 Name of Determination

This Determination is the FMA Act Determination 2008/07 – Section 32 (Transfer of Functions from AGD to PM&C).

2 Commencement

This Determination is taken to have commenced on 10 January 2008.

3 Amendment of Appropriation Act (No. 1) 2006-2007

Schedule 1 amends the *Appropriation Act (No. 1) 2006-2007* to transfer an amount of \$515,273.81 of the departmental item for the Attorney-General's Department to the departmental item for the Department of the Prime Minister and Cabinet.

Note The amount transferred relates to the transfer of the Information Law Branch function.

4 Amendment of Appropriation Act (No. 1) 2007-2008
