Part 5 Disclosure for purpose mentioned in paragraph 46 (d) of Australian Passports Act

1. All courts of the Commonwealth, and of each State and Territory, responsible for family law and related matters.

The Secretary of Attorney-General's Department when acting as the Commonwealth Central Authority for the purposes of the *Hague Convention of 25 October 1980 on the Civil Aspects of International Child Abduction* or the *Hague Convention of 19 October 1996 on Jurisdiction, Applicable Law, Recognition, Enforcement and Co-operation in Respect of Parental Responsibility and Measures for the Protection of Children*.
