1 Name of Regulations

These Regulations are the *Airports (Control of On-Airport Activities) Amendment Regulations 2010 (No. 1)*.

2 Commencement

These Regulations commence on the day after they are registered.

3 Amendment of *Airports (Control of On-Airport Activities) Regulations 1997*

- (b) a person who is an authorised officer for Part 1A.
