# 1 Name of Standards

These Standards are the Disability (Access to Premises — Buildings) Amendment Standards 2010 (No. 1).

# 2 Commencement

These Standards commence on the commencement of the Disability (Access to Premises — Buildings) Standards 2010.

*Note 1* Section 1.2 of the *Disability (Access to Premises — Buildings) Standards 2010* provides that the Standards will commence on 1 May 2011.

*Note 2* These Standards and the *Disability (Access to Premises — Buildings) Standards 2010* take effect subject to subsection 31 (4) of the *Disability Discrimination Act 1992*.

### 3 Amendment of Disability (Access to Premises — Buildings) Standards 2010

Schedule 1 amends the Disability (Access to Premises — Buildings) Standards 2010.

# [1] Paragraph 2.1 (1) (b)

- (b) a new part, and any affected part, of a building, if the building is:
  - (i) a specified Class 1b building; or
  - (ii) a Class 2 building that:
    - (A) is a new building; and
    - (B) has accommodation available for short-term rent; or
  - (iii) a Class 3, 5, 6, 7, 8, 9 or 10 building;

  - (a) from the main points of a pedestrian entry at the allotment boundary; and
  - (b) from another *accessible* building connected by a pedestrian link; and
  - (c) from any *required accessible* carparking space on the allotment.

### [6] Schedule 1, after paragraph D3.3 (f)

insert

- (g) clause 7.4.1 (a) of AS 1428.1 does not apply and is replaced with 'the pile height or pile thickness shall not exceed 11 mm and the carpet backing thickness shall not exceed 4 mm'; and
- (h) the carpet pile height or pile thickness dimension, carpet backing thickness dimension and their combined dimension shown in figure 8 of AS 1428.1 do not apply and are replaced with 11 mm, 4 mm and 15 mm respectively.
