Financial Management and Accountability Act 1997

I, TIM YOUNGBERRY, First Assistant Secretary, Financial Reporting and Cash Management Division, Department of Finance and Deregulation, make this Determination under subsection 32(2) of the *Financial Management and Accountability Act 1997* (the *FMA Act*).

This Determination is made due to a decision of the Australian Government to transfer all activities of an administrative nature associated with the Queensland Fisheries Joint Authority, the Western Australian Fisheries Joint Authority, the Northern Territory Fisheries Joint Authority and the Torres Strait Protected Zone Joint Authority from the Department of Agriculture, Fisheries and Forestry to the Australian Fisheries Management Authority.

1 Name of Determination

This Determination is the *Financial Management and Accountability Act* 1997 Determination 2010/20 — Section 32 (Transfer of Function from DAFF to AFMA).

Note 1: This Determination has been made by a delegate of the Secretary of the Department of Finance and Deregulation. The Secretary is a delegate of the Minister for Finance and Deregulation in accordance with section 62 of the FMA Act. Note 3: On 29 March 2010 the Minister for Agriculture, Fisheries and Forestry agreed to transfer all activities of an administrative nature associated with the Queensland Fisheries Joint Authority, the Western Australian Fisheries Joint Authority, the Northern Territory Fisheries Joint Authority and the Torres Strait Protected Zone Joint Authority from the Department of Agriculture, Fisheries and Forestry to the Australian Fisheries Management Authority.

This Determination commences on the day on which it is made.
