Financial Management and Accountability Act 1997

I, TIM YOUNGBERRY, First Assistant Secretary, Financial Reporting and Cash Management Division, Department of Finance and Deregulation, make this Determination under subsection 32(2) of the *Financial Management and Accountability Act 1997* (the FMA Act).

This Determination is made due to a decision of the Australian Government to abolish the Office of the Australian Building and Construction Commissioner and transfer all functions to the Office of the Fair Work Building Industry Inspectorate.

1 Name of Determination

This Determination is the Financial Management and Accountability Act 1997 Determination 2012/17 — Section 32 (Transfer of Functions from ABCC to FWBII).

Note 1: This Determination has been made by a delegate of the Secretary of the Department of Finance and Deregulation. Note 3: Due to a Government decision, ABCC is to be abolished as at 31 May 2012 and all functions will be transferred to FWBII.

2 Commencement

This Determination commences on 1 June 2012.

3 Amendment of Appropriation Act (No. 1) 2010-2011
