1 Name of regulation

This regulation is the *Criminal Code (Terrorist Organisation—Al-Qa'ida in Iraq) Regulation 2013.*

2 Commencement

This regulation commences on the day after it is registered.

3 Authority

This regulation is made under the Criminal Code Act 1995.

4 Schedule(s)

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

5 Definition

In this regulation:

Code means the *Criminal Code*.

6 Terrorist organisation—Al-Qa'ida in Iraq

- (1) For paragraph (b) of the definition of *terrorist organisation* in subsection 102.1(1) of the Code, the organisation known as Al-Qa'ida in Iraq is specified.
- (2) Al-Qa'ida in Iraq is also known by the following names:
 - (a) Al-Qa'ida in Iraq—Zarqawi;
 - (b) Al-Qa'ida of Jihad in the Land of the Two Rivers;
 - (c) Al-Qa'ida of Jihad Organization in the Land of the Two Rivers;
 - (d) Al-Tawhid;
 - (e) Al-Tawhid and al-Jihad;

- (g) Brigades of Tawhid;
- (h) ISI;
