1 Name of determination

This determination is the *Veterans' Entitlements (Warlike Service—Operation Slipper) Determination 2014*.

2 Commencement

This determination commences on 1 July 2014.

3 Authority

This determination is made under the definition of *warlike service* in subsection 5C(1) of the *Veterans' Entitlements Act 1986*.

4 Schedule(s)

Each instrument that is specified in a Schedule to this instrument is amended or repealed as set out in the applicable items in the Schedule concerned, and any other item in a Schedule to this instrument has effect according to its terms.

5 Definitions

In this determination:

Act means the Veterans' Entitlements Act 1986.

ADF means the Australian Defence Force.

6 Warlike service

For the definition of *warlike service* in subsection 5C(1) of the Act, service in an operation mentioned in an item of the following table is warlike service for the purposes of the Act if the service:

- (a) is in an area of operation mentioned in that item; and
- (b) occurs during a period mentioned in that item.
