1 Name of declaration

This declaration is the *Legislative Instruments (Agricultural Export Instruments)* Sunset-altering Declaration 2014.

2 Commencement

This declaration commences on the day after it is registered.

3 Authority

This declaration is made under subsection 51A(1) of the *Legislative Instruments Act* 2003.

4 Repeal of agricultural export instruments to facilitate review etc.

- (1) Each instrument mentioned in Schedule 1 is repealed on 1 April 2020.
- (2) The instruments mentioned in Schedule 1:
 - (a) would, apart from this declaration, be repealed by section 50 of the *Legislative Instruments Act 2003*; and
 - (b) are or will be the subject of a single review.
- (3) The making of this declaration will facilitate the undertaking of the review of the instruments and the implementation of its findings.

5 Repeal of this declaration

This declaration is repealed on 2 April 2020.
