**"Commissioner, Tertiary Education Quality and Standards Agency:**  
Emeritus Professor Clifford Walsh will receive Total Remuneration of \$261,576 (base salary of \$190,952) while his routine pattern of work remains the equivalent of four full-time days per week. During this period he is also entitled to an accommodation allowance of up to \$34,500 per year (subject to expenditure) to meet commercial rental costs in Melbourne and reunion fares of up to \$18,000 per year (subject to expenditure) for travel between his home locality and Melbourne."
