 - (o) Shabaab;
 - (p) The Popular Resistance Movement in the Land of the Two Migrations;
 - (q) The Unity of Islamic Youth;
 - (r) The Youth;
 - (s) Ugus;
 - (t) Young Mujahideen Movement;
