

5 Terrorist organisation—Kurdistan Workers' Party

- (1) For paragraph (b) of the definition of *terrorist organisation* in subsection 102.1(1) of the *Criminal Code*, the organisation known as Kurdistan Workers' Party is specified.
- (2) Kurdistan Workers' Party is also known by the following names:
 - (a) Freedom and Democratic Congress of Kurdistan;
 - (b) Hezan Parastina Gel;
 - (c) Kongra Gel;
 - (d) Kongra Gele Kurdistan;
 - (e) Kurdish Freedom Falcons;
 - (f) Kurdish Liberation Hawks;
 - (g) Kurdistan Freedom and Democracy Congress;
 - (h) Kurdistan Freedom Brigade;
 - (i) Kurdistan Freedom Hawks;
 - (j) Kurdistan Halk Kongresi;
 - (k) Kurdistan Labor Party;
 - (l) Kurdistan Ozgurluk Sahinleri;
 - (m) Kurdistan People's Congress;
 - (n) New PKK;
 - (o) Partiya Karkeren Kurdistan;
 - (p) People's Congress of Kurdistan;
 - (q) People's Defence Force;
 - (r) PKK;
 - (s) Teyrbazên Azadiya Kurdistan.
