#### 1 Name

This is the *Criminal Code (Terrorist Organisation—Palestinian Islamic Jihad) Regulation 2015*.

#### 2 Commencement

(1) Each provision of this instrument specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.

### 5 Terrorist organisation—Palestinian Islamic Jihad

- (1) For paragraph (b) of the definition of *terrorist organisation* in subsection 102.1(1) of the *Criminal Code*, the organisation known as Palestinian Islamic Jihad is specified.
- (2) Palestinian Islamic Jihad is also known by the following names:
  - (a) al-Quds Brigades;
  - (b) Harakat al-Jihad al-Islami fi Filistin;
  - (c) Islamic Jihad;
  - (d) Islamic Jihad Palestine;
  - (e) Islamic Jihad-Palestine Faction and Islamic Holy War.
