**1 Name of Determination**

This Determination is the *Parliamentary Superannuation Age Factors (Surcharge) Determination 2015 (No. 1)*.

**2 Commencement and revocation**

- (a) This Determination commences on the day after it is registered on the Federal Register of Legislative Instruments.
- (b) This Determination revokes the *Superannuation Pension Conversion Factors Determination No. 1/2004* made by the Parliamentary Retiring Allowances Trust on 9 December 2004 under subsection 22A(1) of the *Parliamentary Contributory Superannuation Act 1948*.

**3 Age factors**

For the purposes of section 22A of *Parliamentary Contributory Superannuation Act 1948*, the age factor for a person is determined under Tables A, B, C and D of the Schedule to this Determination, based on:

- (a) whether the person is male or female;
- (b) whether the benefit is a retirement pension or an invalidity pension; and
- (c) the age of the person when the benefit becomes payable.
