Citation

1. This Determination may be cited as the Torres Strait Prawn Fishery Fishing Season Determination 2015.

Commencement

Determination of the fishing season

- 4. The fishing season in the Torres Strait Prawn Fishery for a particular year is the period specified as follows:
 - a) for the 2016 year, the period from 6 pm on 1 February 2016 to 6 am on 1 December 2016 local time;
 - b) for the 2017 year, the period from 6 pm on 1 February 2017 to 6 am on 1 December 2017 local time;
 - c) for the 2018 year, the period from 6 pm on 1 February 2018 to 6 am on 1 December 2018 local time;
 - d) for the 2019 year, the period from 6 pm on 1 February 2019 to 6 am on 1 December 2019 local time;
 - e) for the 2020 year, the period from 6 pm on 1 February 2020 to 6 am on 1 December 2020 local time;
 - f) for the 2021 year, the period from 6 pm on 1 February 2021 to 6 am on 1 December 2021 local time;
 - g) for the 2022 year, the period from 6 pm on 1 February 2022 to 6 am on 1 December 2022 local time;
 - h) for the 2023 year, the period from 6 pm on 1 February 2023 to 6 am on 1 December 2023 local time;
 - i) for the 2024 year, the period from 6 pm on 1 February 2024 to 6 am on 1 December 2024 local time; and
 - j) for the 2025 year, the period from 6 pm on 1 February 2025 to 6 am on 1 December 2025 local time.
