1 Name of Determination

This Determination is the *Military Rehabilitation and Compensation (Members – War Artists and Entertainers - Service End Date) Amendment Determination 2015*.

2 Commencement

This Determination commences when the *Safety, Rehabilitation and Compensation (Definition of Employee – War Artists and Entertainers) Notice 2015* commences.

3 Saving and application

- (b) *the Military Rehabilitation and Compensation (Members) Determination 2007*;

is, on the commencement of this instrument, a member under, respectively:

- (c) *the Military Rehabilitation and Compensation (Members) Determination 2006 (No.2)*; or
- (d) *the Military Rehabilitation and Compensation (Members) Determination 2007*;

as amended by this instrument.

4 Amendment

- (2) The *Military Rehabilitation and Compensation (Members) Determination 2007* is amended in accordance with Part B of the Schedule.

Note: under subsection 36(1) of the <i>Acts Interpretation Act 1901</i> a period expressed to continue until a specified day – includes that day. |
