## 1 Name

This is the *Export Control (Fees) Amendment (Tariff Rate Quotas) Order 2016*.

## Schedule 1—Amendments

### *Export Control (Fees) Order 2015*

#### **1 Section 5 (paragraph (a) of the definition of export document)**

Omit “or a government certificate”, substitute “, a tariff rate quota certificate or a government certificate”.

#### **2 Section 5**

Insert:

*tariff rate quota certificate* means a certificate that is issued under an order made under section 23A of the Act.

#### **3 At the end of subsection 6(1)**

Add:

; (o) goods in relation to which an application for a tariff rate quota certificate has been made.

#### **4 Section 10 (table item 5, column 1)**

After “export document”, insert “(other than a tariff rate quota certificate)”.

#### **5 Section 10 (after table item 5)**

Insert:

#### **6 Section 10 (table item 6, column 1)**

After “Provision of”, insert “any”.

#### **7 Section 10 (table item 6, column 1)**

Omit “5”, substitute “5A”.

#### **8 Section 10 (before the note)**

Insert:

Note 1: The assessment of an application for the issue of a tariff rate quota certificate for the export of meat or meat products or milk or milk products is covered by item 3 or 4 (see the definition of *export document* in section 5).

#### **9 Section 10 (note)**

Omit “Note”, substitute “Note 2”.
