**Determination 2016/02:
Remuneration and Allowances for Holders of Public Office
and Principal Executive Office**

- (i) Pursuant to subsections 7(3) and 7(4) of the Remuneration Tribunal Act 1973, the Remuneration Tribunal has inquired into the remuneration and allowances to be paid to certain holders of public office, and other matters significantly related thereto, and determines as set out below.

PART 1 – FULL-TIME OFFICES

- 1.1 In this part, Determination Number 21 of 2015 (as amended) is referred to as the Principal Determination.
1.2 Table 2A of Part 2 of the Principal Determination is amended by inserting the following entry after the entry for "Vice President, Fair Work Commission".

- 1.3 Table 2A of Part 2 of the Principal Determination is amended by replacing the current entry for the "Inspector-General Australian Defence Force" with the following entry and placing it after the entry for "Chair, Australian Accounting Standards Board".

- 2.4** Schedule A of the Principal Determination is amended by deleting sub-clause "A12" in the Additional Sub-clauses to Table A.
- 2.5** Table B3 of Schedule B of the Principal Determination is amended by deleting "B3.18" from Column 5 of the entry for "Referendum Council".
- 2.6** Schedule B of the Principal Determination is amended by deleting sub-clause "B3.18" in the Additional Sub-clauses to Table B3.
- 2.7** Table A of Schedule A of the Principal Determination is amended by inserting the following entries after the entry for "Airservices Australia".
