1 Name

This is the *Criminal Code (Terrorist Organisation—Al-Qa’ida in the Lands of the Islamic Maghreb) Regulation 2016*.

2 Commencement

3 Authority

This instrument is made under the *Criminal Code Act 1995*.

5 Terrorist organisation—Al-Qa’ida in the Lands of the Islamic Maghreb

- (1) For the purposes of paragraph (b) of the definition of **terrorist organisation** in subsection 102.1(1) of the *Criminal Code*, the organisation known as Al-Qa’ida in the Lands of the Islamic Maghreb is specified.
- (2) Al-Qa’ida in the Lands of the Islamic Maghreb is also known by the following names:
- (a) Al Qaida au Maghreb Islamique;
 - (b) Al-Qa’ida in the Islamic Maghreb;
 - (c) Al-Qa’ida Organisation in the Lands of the Islamic Maghreb;
 - (d) AQIM;
 - (e) Le Groupe Salafiste Pour La Predication et Le Combat;
 - (f) Salafist Group for Call and Combat;
 - (g) Salafist Group for Preaching and Combat;

(h) Tanzim al-Qa'ida fi bilad al-Maghreb al-Islamiya.
